

FAMILY REUNIFICATION REQUIRED DOCUMENTS - 2nd stage (DECISION-VISA)

APPLICANTS ALREADY INTERVIEWED BY THE EMBASSY AT THE 1ST STAGE SUBMIT ONLY DOCUMENTS no 1 -5. FOR CASES NOT EXAMINED AT THE 1ST STAGE, ALL BELOW MENTIONED DOCUMENTS ARE SUBMITTED.

1	Application form for a visa for a long stay in Greece , fully filled in and signed by the applicant	
2	One recent passport-size photograph in colour with white background, according to the relevant specifications laid down by ICAO	
3	All passports (current and, if applicable, previous). The current passport must: -be of a validity exceeding by three months the ending date of the visa length - include at least two blank pages -have been issued within the previous ten years.	
4	Police Clearance Certificate , recent and duly attested * (not required for minors under 12 years old)	
5	Medical Fitness Certificate , upon request by the Consular Office after the Interview (see Note no 4)

* - For citizens of India: the document must be affixed with an Apostille Sticker from the Ministry of External Affairs New Delhi

- For citizens of Bangladesh: the document must be attested by the Ministry of Foreign Affairs of Bangladesh, Dhaka

- For citizens of Nepal: the document must be attested by a) the Ministry of Foreign Affairs of Nepal, Kathmandu and b) the Honorary Consulate of Greece in Kathmandu or the Embassy of Nepal in New Delhi

- For citizens of Sri Lanka: the document must be attested by the Ministry of Foreign Affairs of Sri Lanka, Colombo.

Note:

- 1) *Original documents and passports submitted must be accompanied along with a copy*
- 2) *All documents submitted, if not in Greek or English, should be accompanied by an English translation*
- 3) *The applicant may be asked for additional documents*
